**Background:** TSTC has an approved policy to honor or memorialize individuals and

businesses that have made major contributions or performed outstanding service for the college by naming buildings, definable portions of buildings, geographic areas, and organizational entities for such individuals and

businesses.

James R. Pitts, known to the residents of North Texas and Ellis County as Jim Pitts, represented District 10 as the elected State Representative to the Texas Legislature from 1993 to 2015. Representative Pitts was appointed by two

Speakers of the Texas House to serve as chairman of the powerful Appropriations Committee, serving more than eight years in total in that position. He was chairman during the 79<sup>th</sup> Legislature and, again, during the

81<sup>st</sup>, 82<sup>nd</sup>, and 83<sup>rd</sup> Legislatures.

An attorney and business owner in Waxahachie, Pitts has served on many local boards and commissions to include 14 years on the board of trustees for the Waxahachie Independent School District. In 1999, the community named him

"Outstanding Citizen for the Year."

**Justification:** During his last term in office, Representative Pitts was instrumental in

bringing together economic development groups and school superintendents

from across the region to build a TSTC campus in Red Oak. He also championed legislative funding for the campus. Renaming the Industrial Technology Center on the TSTC North Texas campus recognizes James R. Pitts' long career as a public service and his efforts to create the campus.
